#### Review of November 17, 2022 Board Minutes

#### **Committee Reports**

Treasurer Tom Goldrick:

• Tom presented the September Treasurer's report. He reported he miscounted the monthly transactions with Wells Fargo, and we had a \$9.00 service charge. Interest made this month was \$0.23. Banquet cost were finalized and we were \$29 in the plus column. Last month tournament was cancelled with all refunds made to our members/players.

Tournament Director Charles Starr:

 Charlie recapped on our first frost delay with Craig having to redo the tee sheet. Everyone finished in a timely manner. Tournament committee also reviewed the member-member tournament. We had 144 members playing with two groups not finishing due to darkness. We discussed making it a requirement to have played in 3 club events to be eligible to play in the member-member tournament but trying to keep track of it would be too time intensive.

Handicap Director Ed Foy:

• Ed stated there are no issues at this time. He has been randomly checking Chelsea ensuring members are entering their score, and he doesn't see any problems.

Membership Director Tom Jones

• Tom stated we have 427 active members. 382 are renewals and 45 are brand new members since Oct 1st. We also have 126 members that have yet to renew their membership. As of the first of January 2022 we have 126 new members.

Web Site Director Leon Chapman:

• Leon updated on the changes he made on the web site. Hole #7 on Cimarron had the yardage incorrect. In making the change it affected the default tees which was later fixed. The web site was updated with the members pictures and the description of the different golf games. He updated the database and

corrected all issues. Leon continues to work with Dewey Wald to take over as website director. Dewey has discussed with Leon some new ideas and will be further expanding on it when Dewey gets back from vacation.

## Social Director Craig Boyce

- Craig received some numbers from the upcoming dinners/banquet. The cost for the prime rib dinner will be \$45 per head should we move forward with it. The three-meat combo will be in the upper \$20 range. The March 29th banquet date has some issues with the dining site being outside and with it being the first day of the club championship. Dan did not want to make a decision on the banquet today, and we will discuss it more at the January meeting. On a positive note the purchasing of beer by the can seemed to work well at \$1.25 per can and was recommended that we continue this practice. By moving to can beer it saved us a few hundred dollars less the cost of the kegs of beer. In talking with Roger Roads, he doesn't have the time it requires to get the coupons/gifts cards for the banquet. The men's club will provide gift certificates along with the Grand Pro shop. The amount of the gift certificates will be determined at the January meeting. The members all agreed to the three-meat combo at the January banquet. Dan was approached by Doug about the silent auction and if we are going to have it again. Dan will talk to Gary about if we are going to having the silent auction.
