- Ed provided the breakdown of tees currently in use in the Men's Golf Club as follows: White Tees 102; White/Gold Combo 83; Gold 228; Red 35.
- He also advised that we have a new member with a handicap over 40. Our bylaws state a maximum of 36 be used. Gene advised that Golf Genius is set up for the 36 max. Also, John Gavazza advised that this person's handicap has come down to 40 and it would adjust to 36 or less on each course, so there is no issue.

Kevin provided samples of the new scorecards for GFN and GFS with the new tee markings and new rating for new tee box (Orange) on GFS. The change in the tee colors will be effective when the courses are re-opened after overseeding. The current Blue tees will be Black, White will be Blue, Gold will be White, Red will be Gold, Orange will be Red and the new tee boxes will be Orange as each course is converted.

New bulletin boards are being installed at the Snack Shop areas.
