Leon passed out a handicap conversion chart that may be helpful the tournament managers at the sign-in desk. The World Handicap System option in Golf Genius was activated and will be used for the January 22 tournament.

Social Chairman Ray Wilton:

Golf Advisory Committee- Mike Domino:

The GAC has recommended to the Board that the Drive/Chip/Putt event be held at SCG annually. Turf reduction, renovation of some bunkers, and construction of additional tees are also being discussed by the GAC. A Granite Falls North pump station is being replaced. The GAC is going to be taking a survey of the residents about golf.

Golf Staff: Kevin Reagan

Work on irrigation system is being done. No handicap cards (available from USGA) will be available with the WHS because the system updates handicaps daily. TV's at the courses used for live scoring can also be used to "advertise" the Men's Club using Golf Genius. Kevin will get with Leon to look into this. The settings on the TV's have been changed so that the TV's do not go to sleep but instead will display the leaderboard continually. The SCG courses were rated by an independent outside organization. The ratings were very favorable for all the courses with the exception of Granite Falls North.
