### Review/Approval of December 20, 2018 Board Minutes

### **Committee Reports**

Treasurer Doug Brady:

- (1) Doug passed out the financial statement (see attached).
- (2) Gary moved that the statement be accepted. Wayne seconded the motion. The motion passed.
- (3) Doug noted that the revised budget will be submitted to CAM.

**Tournament Director Charles Starr** 

- Charlie announced that the starting tee time has been moved from 9:00am to 8:30am to accommodate the increase in sign-ups for tournaments.
- (2) Charlie and Ron met with Jeff Hochman regarding the pace of play. It was agreed that the starters will emphasize keeping up with the group in front of you. Also, the rangers will enforce current Sun City Grand golf course slow play policy by warning players twice about slow play and if no improvement is made then the groups will be asked to pick-up their balls and move to the next tee. In the case of the Men's Club, players who are asked to pick up will be disqualified from the tournament. Ron passed out a draft of a policy statement regarding pace of play and after finalization will be sent out to club members by email. It was agreed that this policy should be issued.
- (3) To encourage good pace of play, the time clock will be re-introduced. Wayne volunteered to do the analysis of the time clock data.
- (4) Randy questioned why the tournament for January 16 was cancelled. Ron noted that a good number of our players cannot play when course conditions restrict carts to the cart path. Charlie noted that the tournament was cancelled but the tee times reserved by the Men's Club were not cancelled. Charlie's email to those on the tournament roster noted that members should contact the Cimarron pro shop if they wish to cancel their tee time.

    - ii. Rock rule
    - iii. Accidental Movement of Ball on the Putting Green
- (3) Optional USGA Local Rule regarding out-of-bounds. This optional rule would allow the player to drop the ball on the fairway at the point that it left the fairway with a two stroke penalty. It was the consensus of those present that the Men's Club will not adopt this rule.
