It was determined that a quorum is present with 5 of the 6 elected officers present.

President Gipson opened the meeting at 2:00pm.

### Review/Approval of July 18, 2019 Board Minutes

Bill DiOrio moved that the minutes of August 15, 2019 Board meeting be approved. Tom seconded motion. The motion passed.

### **Committee Reports**

Treasurer Doug Brady:

In Doug's absence it was agreed acceptance the financial report would be tabled and the report would be presented to the Board at the October Board meeting.

Tournament Director Charles Starr:

- (1) Charlie thanked Gene, Ron and Jim for their work on the tournaments this summer.
- (2) There was a 5-way tie for first place in flight 1 for the September 18 tournament.
- (3) There will be a training session for tournament managers. October 1 is the tentative date for this training.

Handicap Chairman Ed Foy:

Leon inquired why we don't post weekly tournaments as "tournament scores." Ed responded that the USGA handicap manual states "tournament scores" are posted only for special events and should not be posted for weekly events. The Club considers the Club Championship as a special tournament and scores are posted as "tournament scores".

Membership Chairman Tom Martin:

- (1) The Club now has 461 members.
- (2) Tom asked for comments on the membership form.

(3) Bill DiOrio suggested membership forms be placed at each pro shop. After some discussion it was felt that putting the forms only at the Granite Falls pro shop was adequate.

# Web Site Manager Leon Chapman:

- (1) New e-mail addresses have been created for Club officers, tournament managers and scorers. These e-mail addresses are linked to the private email addresses of those affected.
- (2) Leon showed that the points used in Quota tournaments have not been correct. In the tournament set-up. Golf Genius uses 1=bogey, 2=Par, 3=Birdie, and Eagle=4 as a default. This is not correct. The correct points for a Quota Tournament are as follows: Bogey=1, Par=2, Birdie=4, Eagle=8, Double Eagle= 12. This is consistent with the Quota tournament description on the Men's Club web site. These points have to be entered into the correct field for each Quota tournament. (Subsequent to the meeting, Gene Benting noted that 2 of the 4 Quota Tournaments had the wrong points assigned. The other 2 tournaments were correct.)
- (3) The results of tournaments have been condensed on the web site.

# Social Chairman Steve Robinson:

- (1) The 2019 Fall Banquet will be held in the Kiva Room and the 3-meat combo will be served. Dillon's has quoted a price of \$22/head. Kevin has told Steve that Puma Golf and Taylor Made would like to have tables at this event. The consensus was this would be welcomed. Steve will be working with Kevin on this.
- (2) Steve passed out the 2020 room assignments. They are as follows:
